

Terms & Conditions

1. Powerbase Powerpoints 2011/2012 commences 1 April 2011 and concludes 31 March 2012.
2. Only trade customers of Powerbase members are entitled to apply to register for Powerbase Powerpoints 2011/2012.
3. Customers must register or re-register into the programme in order to receive Powerpoints for purchases. Customers must apply and register into the target plan part of the promotion and agree on a purchase target in order to receive extra points. When a customer re-registers into the Powerpoints programme, any unused points from the previous year will roll-over into that customer's account subject to the terms and conditions applying. If an account is not re-registered or is inactive for over 12 months, any reward credit will expire.
4. A completed application form is subject to acceptance by a Powerbase member and acceptance to participate in Powerbase Powerpoints 2011/2012 is solely at the discretion of the Powerbase member.
5. The completion of an application form for Powerbase Powerpoints 2011/2012 by a customer constitutes agreement by that customer with all the terms and conditions applying to the promotion and to making a valid claim under the promotion.
6. Such terms and conditions may be amended from time to time without notice as is deemed appropriate, at the sole discretion of Powerbase Inc. and the right to make amendments includes the right to vary, cancel or revoke the Powerbase Powerpoints 2011/2012 promotion in whole or in part if Powerbase Inc. deems any circumstances warrant such a decision.
7. The decision of Powerbase Inc. or of a Powerbase member in all matters relating to the interpretation of the rules and conditions and the application of the terms and conditions will be final and binding on all applicants and registered customers. No correspondence will be entered into.
8. In order for the reward claim to be made against a Powerbase Powerpoints 2011/2012 total, the customer's account with the Powerbase member must be maintained within the payment terms agreed between the Powerbase member and the customer.
9. At the sole discretion of the Powerbase member a customer's rewards may be forfeited due to the customer's failure to meet the agreed payment terms.
10. The value of goods returned for credit will be deducted from purchase dollar values before the calculation of the customer's Powerpoints. All purchase dollar values exclude GST.
11. Any taxation liability on customer's participation in Powerbase Powerpoints 2011/2012 or on rewards earned under the promotion is the sole responsibility of the customer and not the Powerbase member. Customers may wish to receive advice from their own taxation adviser or accountant.
12. Powerbase Inc. and its members accept no responsibility or liability where a product or products are not available for sale for any reason resulting in Powerpoints not being earned on potential sales.
13. Rewards earned under the Powerbase Powerpoints 2011/2012 promotion are subject to the following rules:
 - For a reward claim to be processed the customer must have registered or re-registered in the current Powerbase Powerpoints promotion.
 - Rewards are issued to and are the property of the account holder named on the registration form.
 - Registered customers must earn 100 Powerpoints to be eligible to claim rewards. When the 100 points threshold has been reached then rewards may be claimed to any value to which the customer is entitled.
 - In the event of a claim from a deceased estate, Powerpoints claims will be honoured subject to all current Terms and Conditions of the Powerbase Powerpoints programme having been met.
 - If points from a previous Powerpoints Reward have been rolled over, it is essential to re-register in Powerbase Powerpoints 2011/2012 in order to claim on the rolled over points. Re-registration must be completed by 31 May 2011 or at the sole discretion of the Powerbase member the points may be cancelled.
 - Powerbase Inc. and its members reserve the right to substitute any reward offered with a similar reward of approximately the same value and similar features.
 - Powerbase has taken care to select rewards that are available at the conclusion of this promotion at the points value nominated but Powerbase cannot be responsible for rewards not being available at the time of claiming or for Powerpoints values having changed by that time.
 - Rewards received by customers come with the manufacturer's or supplier's guarantee or warranty only and no further guarantee or warranty is provided by Powerbase Inc. or any member.
 - All travel rewards are subject to availability and to the normal conditions of carriage of the airline concerned.
 - Powerbase Inc. and its members accept no liability or responsibility for damage or loss to persons or property caused directly or indirectly by any reward received under the Powerbase Powerpoints 2011/2012 promotion.
 - Powerbase members will endeavour to meet requests to redeem rewards that are not illustrated in the Powerbase Powerpoints 2011/2012 brochure. Rewards which are not illustrated in the Powerpoints catalogue are provided at a further cost (in points) beyond the nominal cost of the reward. In some cases the RRP will be used, in other cases an uplift of at least 10% of points will be applied.
14. Powerbase members and their staff are not eligible for Powerbase Powerpoints 2011/2012.
15. Claims for rewards under Powerbase Powerpoints 2011/2012 are subject to the following rules:
 - All claims are subject to the rules and conditions of Powerbase Powerpoints 2011/2012.
 - All claims require approval by the Powerbase member company and are checked and validated before being processed.
 - A valid, approved reward claim form must include the nomination of a person to receive the reward. Any dispute as to the ownership or receipt of rewards must be resolved by the customer and the claimant.
 - Each claim must be completed on a separate claim form but registered customers may make as many claims as they are entitled to during the course of the promotion.
 - By claiming rewards winners agree to Powerbase Inc. or a member company using the winner's name and photograph for any publicity purposes.
16. By signing an application form to register into Powerbase Powerpoints 2011/2012 customers acknowledge that information on the registration form and any claim form under the promotion is retained and used for the purposes of the promotion. Customers may ask for any incorrect information held to be corrected in accordance with the Privacy Act.
